

ABOUT THE SCHOLARSHIP

Pal Buddhist School is offering six full academic need-based bursaries for new incoming students in the local area that are facing financial hardship. This bursary is for driven and ambitious students who do not have the funds to attend a private school. Applications are invited from any students between Year 7 to Year 11. Students must meet the criteria set forth to be considered for the bursary. The five individuals who will be awarded this bursary will be chosen by our academic panel based on their financial hardship and academic standing.

GENERAL CONDITIONS OF THE BURSARIES

The bursary will only cover tuition fees. In order to continue receiving the bursary, the student must maintain good academic standing and adhere to the behaviour policy, which can be found in the Student Handbook. During the time of bursary if the student fails to meet these conditions, their bursary will be reassessed. The bursary is for a continuous enrolment period and ceases when the student withdraws from Pal Buddhist School.

THE APPLICATION PROCESS

Along with the application, the applicant must provide the school with various documents to verify low family income and consistently high academic results.

1. Applicants must provide evidence of financial disadvantage through:
 - a copy of both parent(s)/guardian(s) 2014/2015 Assessment Notice from the Australian
 - a copy of the last 12 months of their parent(s)/guardian(s) bank statements.
2. Applicants must attach school reports from the past 2 years to support their academic standing.
3. If needed, an interview will be scheduled with the applicant.

If necessary, Pal Buddhist School requires the right to request further documents to prove eligibility.

DEADLINE:

FEES

The bursary will cover tuition fees for as long as the student is enrolled in Pal Buddhist School. As mentioned before, if the student decides to leave and then return, the bursary is no longer available.

One uniform set will be given to the student and they will be responsible for any extra sets. An Education Services Levy fee will be charged every year along with the cost of any excursions.
